| Perihal : Pembatalan Kontrak Berkala Emas UBS (UBSG) | Concerning : The Revocation of UBS Gold Periodic Contract (UBSG) |

Sehubungan dengan pembatalan Kontrak Emas Berkala Emas UBS (UBSG) di Bursa Komoditi dan Derivatif Indonesia ("**Bursa**"), maka melalui Surat Edaran Bersama ini Bursa dan *Indonesia Clearing House* ("**Lembaga Kliring**") menetapkan hal-hal sebagai berikut:

In connection with the revocation of UBS Gold Periodic Contract (UBSG) at the Indonesia Commodity and Derivatives Exchange (the "**Exchange**"), through this Joint Circular, the Exchange and Indonesia Clearing House ("**Clearing House**") stipulate the following matter:

1. Pembatalan Kontrak Berkala Emas UBS (UBSG) telah mendapatkan persetujuan dari Bappebti berdasarkan Surat Nomor 181/BAPPEBTI/SD/10/2018 tertanggal 23 Oktober 2018 dengan demikian Kontrak Berjangka Emas UBS (UBSG) tidak lagi ditransaksikan dalam sistem perdagangan Bursa.
 2. Berdasarkan hasil evaluasi yang dilakukan, pembatalan Kontrak Berkala Emas UBS (UBSG) dikarenakan sudah tidak ada transaksi di Bursa.
 3. Bahwa dengan berlakunya Surat Edaran Bersama ini, maka Surat Edaran Bersama Nomor 079/SEB/BKDI-ISI/III/2015 tentang Margin Awal dan Biaya Transaksi Kontrak Berkala Emas UBS, Surat Edaran Bersama Nomor 082/SEB/BKDI-ISI/III/2015 tentang Perubahan Daftar Tempat Penukaran Emas UBS, Surat Edaran BKDI Nomor 020/SE/BKDI/II/2015 tentang Pemberlakuan Peraturan dan tata Tertib (PTT) BKDI Bab 36 tentang Kontrak Berkala Emas UBS, dicabut dan dinyatakan tidak berlaku lagi.
 4. Ketentuan-ketentuan dalam Surat Edaran Bersama ini dapat diubah dari waktu ke waktu.
 5. Surat Edaran Bersama ini mulai berlaku sejak tanggal ditetapkan.
1. The revocation of UBS Gold Periodic Contract (UBSG) has been approved by CoFTRA based on Letter Number 181/BAPPEBTI/SD/10/2018 dated 23rd October 2018 therefore UBS Gold Periodic Contract (UBSG) is no longer transacted on the Exchange trading platform.
 2. Based on the results of the evaluation, revocation of the UBS Gold Periodic Contract (UBSG) due to no transactions in the Exchange.
 3. With the enactment of this Joint Circular, Joint Circular Number 079/SEB/BKDI-ISI/III/2015 on Initial Margin and Transaction Fee for UBS Gold Periodic Contract, Joint Circular Number 082/SEB/BKDI-ISI/III/2015 on the List Changes of Replace UBS Gold, Circular 020/SE/BKDI/II/2015 on the Enactment of ICDX Rules Chapter 36 on UBS Gold Contract, shall be ceased to effect.
 4. Provisions as referred in this Joint Circular are subject to change from time to time.
 5. This Joint Circular shall be effective on the date of the stipulation.

Demikian Surat Edaran Bersama ini agar dapat dipedomani dan dilaksanakan sebagaimana mestinya.

Now therefore, this Joint Circular may be referred to and executed accordingly.
